LOAD

COLOREX-2MR-HP

- TOXIC SOLID ORGANIC NOT OTHERWISE SPECIFIED
- Powder or crystals - Usually with perceptible odour
- Partly soluble in water
- Emergency Action Code : 2X

NATURE OF DANGER

- Toxic
- The substance poisons: by inhalation, by ingestion, by absorption through skin
- Causes severe damage: to eyes, to skin, to air passages
- Decomposition in a fire. production of toxic fumes. The effect of inhalation may be delayed
- Heating or reaction with acids or oxidizing agents may cause explosion
- May assist fire in burning materials

PERSONAL PROTECTION

- Suitable respiratory protective device
- Goggles giving complete protection to eyes
- Plastic or rubber gloves. Boots
- Eyewash bottle with clean water
- Two self-standing warning signs, handlamp, warning vest

GENERAL ACTIONS BY THE DRIVER

- Stop the engine
- No naked lights. No smoking
- Mark roads with self-standing warning signs and warn other road users or passers-by
- Keep public away from danger area. Keep upwind
- Notify police and fire brigade as soon as possible

ADDITIONAL AND/OR SPECIAL ACTIONS BY THE DRIVER

- Any action only if without personal risk
- If practicable: use shovel, broom, small collecting container
- Avoid direct contact with substance
- Stop leaks if without risk
- Cover spilled substance with earth or sand or other suitable material
- If substance has entered a water course or sewer or been spilt on soil or vegetation, advise police

FIRE (information for the driver in case of fire)

- Do not attempt to deal with any fire involving the load

FIRST AID

- Remove contaminated clothing immediately and wash affected skin with soap and water
- If substance has got into the eyes, immediately wash out with plenty of water. Continue treatment until medical assistance is provided
- Seek medical treatment when anyone has symptoms apparently due to inhalation, swallowing or contact with skin or eyes
- Persons who have inhaled the gas or fumes produced in a fire or who have come into contact with the substance may not show immediate symptoms. They should be taken to a doctor with this card
- Patient must be kept under medical supervision for at least 24 hours

SUPPLEMENTARY INFORMATION FOR EMERGENCY SERVICES

- Do not flush road with water
- Keep container(s) cool by spraying with water if exposed to fire
